General Club Rules and By-Laws

- Annual membership dues are non-refundable. Great Rock Golf Club reserves the right to review any extenuating circumstances regarding membership suspension, leave of absence, etc. All decisions made by Great Rock management are final.
- A member is entitled to full privileges of the club once their membership deposit has been received for the current year. If the balance is not received within the allotted 30-day period, however, privileges will be suspended until the balance has been collected.
- The hours of operation will be established by the Club and adjusted, as the Club deems necessary.
- Metal Spikes are prohibited on the entire property including the course and clubhouse.
- Proper attire is expected of members and guests. Please check with Club personnel if you have questions regarding proper attire.
- Members are responsible for their guest's behavior and adherence to Club Rules and By-Laws.
- Great Rock Golf Club reserves the right to book outside outings on weekdays or weekends & occasionally the course may be closed for these outings. We will make every effort to accommodate members on outing days.
- All complaints concerning operations of the Club's facilities, employees and other matters are to be directed to the Club Manager. All complaints must be made in writing and signed by complainant for review by the management.
- Any breach of these rules, or conduct in a manner prejudicial to the best interests of the Club, will subject the violator to disciplinary action. Great Rock Golf Club management reserves the right to review any violation of these rules and set punishments, as it deems appropriate. Adjustments of member privileges, fines, and suspension or termination of membership are all within the jurisdiction of the reviewing team.

Golf Rules:

- Members have 14-day advance tee time reservation privileges.
- Members wishing to play in club tournaments must have a handicap at **GREAT ROCK GOLF CLUB**.
- Only two people are permitted to ride in a golf cart.
- Spectators are not permitted on the course.
- Practice on the golf course is prohibited.
- All players must begin on the first hole unless otherwise instructed.
- Maximum of four (4) players per group. No exceptions.
- To facilitate an enjoyable pace of play, members shall familiarize themselves with **READY GOLF** and comply with ranger or starters directions.
- Slower playing groups **MUST** allow golfers behind them to play through if there is an open hole in front of them. Jumping holes to avoid slow play is prohibited. Please notify the ranger or starter of slow groups in front of you if there is a problem.
- It is your obligation to repair ball marks, fill divots with divot mix and to rake bunkers.
- The Club reserves the right to amend or modify these rules whenever necessary and will notify the membership of any changes.
